## Section 5. Fire-fighting measures

### Extinguishing media

- Suitable extinguishing media** : Use an extinguishing agent suitable for the surrounding fire.

**Specific hazards arising from the chemical** : Contains gas under pressure. Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed.

**Special protective actions for fire-fighters** : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. Use water spray to keep fire-exposed containers cool.

### Personal precautions, protective equipment and emergency procedures

If a large number of containers are ruptured, treat as a bulk material spillage according to the instructions in the clean-up section. Shut off all ignition sources. No flares, smoking or flames in hazard area. Put on appropriate personal protective equipment.
